In response, the table below is the record of incidents the LFB have Vandervell Court, 1-55, Larden Road, London, W3 7EU. You did not specify a date range so I have so I have searched any incidents held by the LFB since our electronic records began in 2000.

If attending crews identify any safeguarding concerns during an incident, a Person at Risk (PAR) form is submitted to their relevant Local Authority (Council) to take forward.
