**Request:**

I would like to request information regarding London Fire Brigade attendances at my residence, Wentworth Court (SW18 4BT, Wandsworth), and the adjacent Eliot Court.

Between January 2025 and December 2025, there were numerous fire alarm activations at these properties. My understanding is that this coincided with cladding repair works and the installation of a new fire alarm system. The alarms appeared to be highly sensitive and were triggered frequently, sometimes several times per week and, on occasion, multiple times in a single day.

I would like to request the following information for the period 1 January 2025 to 31 December 2025:

- The total number of occasions on which the London Fire Brigade attended Wentworth Court and/or Eliot Court in response to a fire alarm activation.
- The number of occasions on which a genuine fire was identified.
- Where available, a breakdown showing how many attendances were caused by false alarms or alarm system activations where no fire was found.

If possible, I would appreciate this information in electronic format.

**Response:**

Thank you for your request for information, which we received on 4 June 2026.

In response to your request, please see the table below, which sets out all recorded London Fire Brigade attendances at Wentworth Court and Eliot Court (Wandsworth) for fire alarm activations between 1 January 2025 and 31 December 2025.

The table provides details of all incidents attended at these locations during the requested period, including incidents recorded as fires, false alarms and other types of attendance. This information can be used to identify the total number of attendances, the number of genuine fires, and the number of false alarm activations where no fire was found.

Please note that the information you have requested is also publicly available. A full list of incidents attended by the London Fire Brigade is published through the London Datastore and can be accessed using the links below:

These datasets are updated monthly and contain additional information, including:

- The type of incident (for example, fire, false alarm or special service);

- The date and time of the incident;
- The property type where the incident occurred;
- The location of the incident (including borough, postcode and geographical coordinates);
- Attendance and response times for fire engines;
- The fire station and appliances mobilised to the incident;
- The number of fire engines attending;
- The duration of the attendance; and
- The notional cost of the Brigade's response.
